Potluri Siddhartha Institute of Technology, Kanuru, Vijayawada, Krishna District" from the Academic year 2012-13 to 2017-18, subject to fulfillment of the following conditions:

- a. Prasad V. Potluri Siddhartha Institute of Technology, Kanuru, Vijayawada, Krishna District shall continue its affiliation to JNTUK in future also at least till the recommended period of autonomy expires. The autonomy shall cease to exist on discontinuation of affiliation.
- b. The students presently enrolled in the Prasad V. Potluri Siddhartha Institute of Technology, Kanuru, Vijayawada, Krishna District, shall continue to be governed by the academic regulations of JNTU Kakinada.
- c. The admission procedures to be followed by the Prasad V. Potluri Siddhartha Institute of Technology, Kanuru, Vijayawada, Krishna District shall continue to remain the same as those of APSCHE/JNTUK for various programs run by it even after acquiring autonomous status.

- d. The autonomous status for the Prasad V. Potluri Siddhartha Institute of Technology, Kanuru, Vijayawada, Krishna District, shall come into force with effect from the academic year 2012-13.
- e. The college shall follow the guidelines issued by the UGC in all matters.
- f. The college shall constitute the necessary Statutory Bodies and inform the University.

- h. These orders are issued subject to ratification by the Monitoring & Development Committee of JNTUK.
